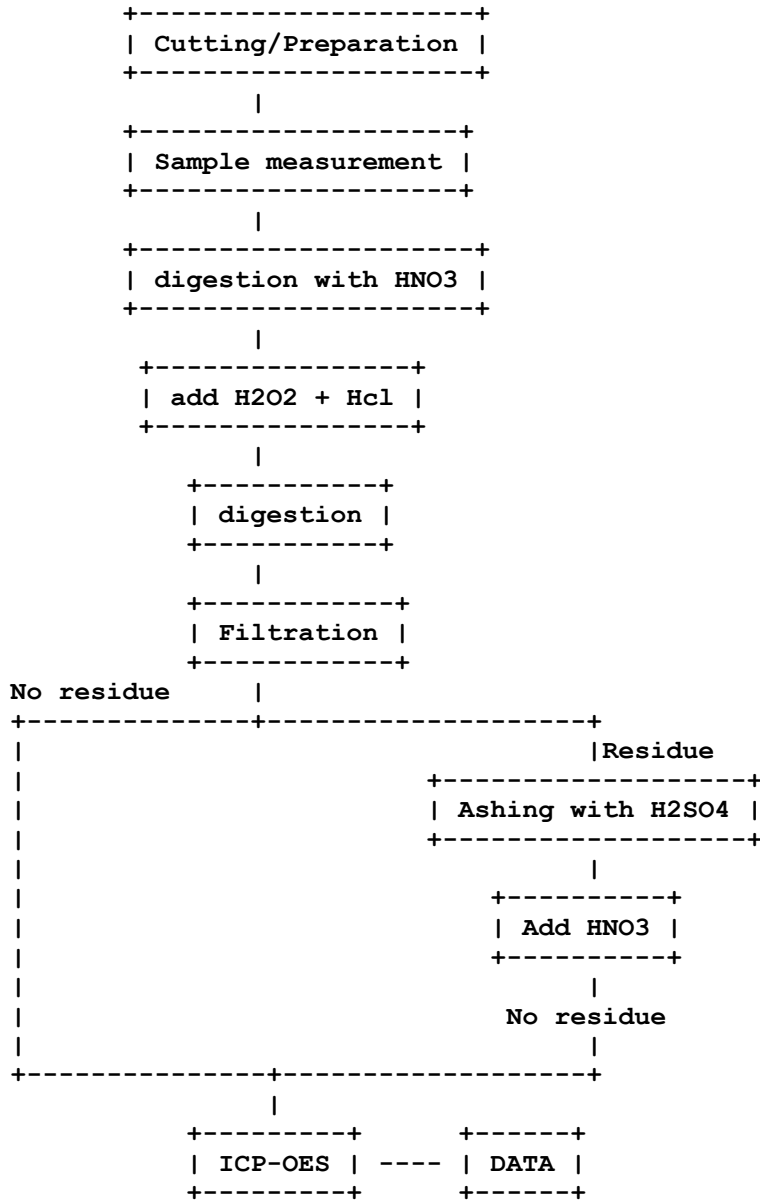

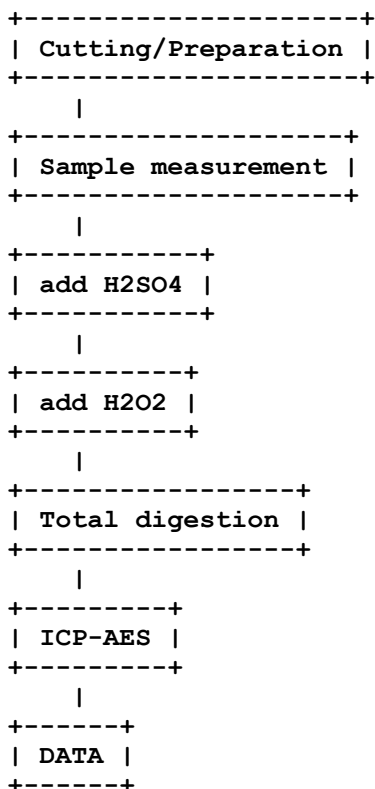

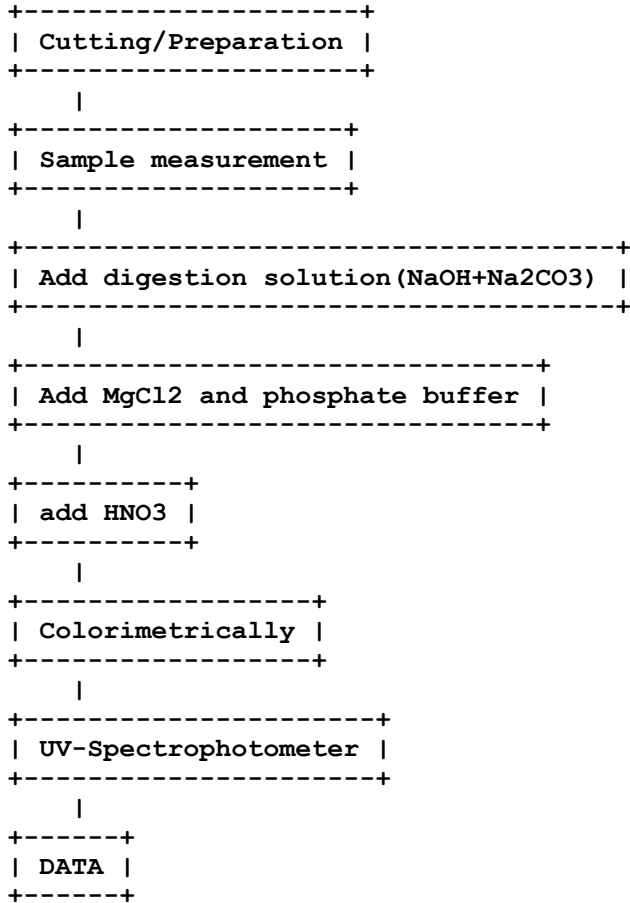

Flow chart of digestion (EPA 3060A,7196A for Cr(VI))



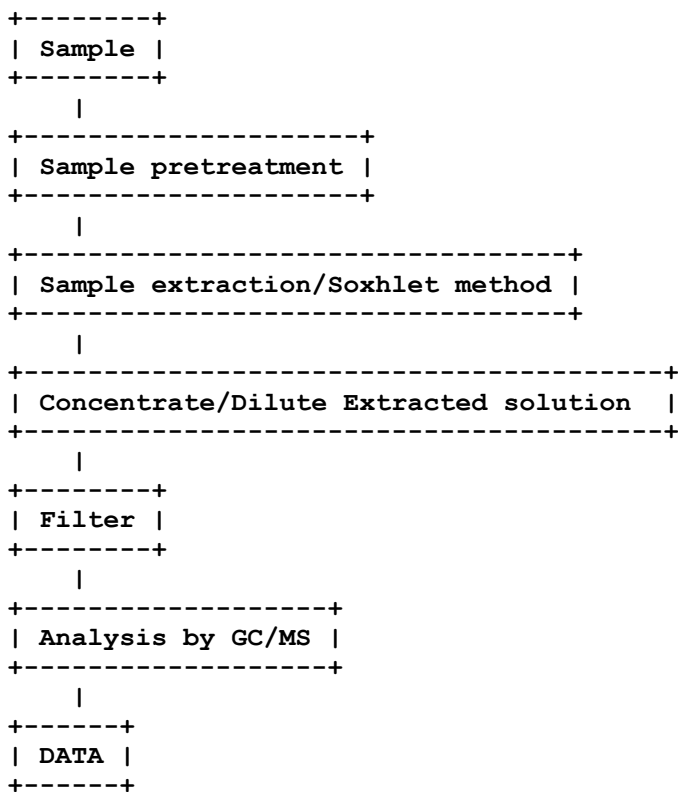
